Your 1098 will be printed on the last page of your December statement if you paid more than \$600 in interest on a home equity loan.

For just a \$35 fee per loan you can skip your Nov, Dec or Jan payment*!

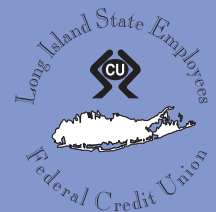
